**SCHOOL YEAR CALENDAR APPROVED 2013-2014** – The Board *approved the 2013-2014 school year calendar* for the Catholic schools in Medicine Hat. The calendar for St. Michael's School in Bow Island will be approved in April 2013. Students in all Catholic schools will return to classes *after the labour day weekend in September 2013*. **EARLY RETIREMENT INCENTIVE PLAN** (ERIP) – The Board of Trustees will hold a <u>Special Board</u> <u>Meeting</u> on <u>Tuesday, April 09, 2013</u> at <u>1:00 pm</u> to review the ERIP applications submitted in accordance with Article 14 of Teachers Collective Agreement. The Board will make a decision on the merit of each ERIP application.

#### BOUNDARY FOR DESERT BLUME AND 4 X 4

The Board voted unanimously to approve the implementation of a *boundary flex-zone* as follows: *All students in Desert Blume can attend either Mother Teresa School or St. Patrick's School* with transportation provided beginning with the 2013-2014 school year. The Board also voted unanimously to *explore the expansion* of our *existing rural 4 x 4 boundary.*

### CATHOLIC TAXES – Declare your support! 🚺

"Speak Out" for faith-based schools and your right to support them with your local taxes. At this time of year you will be receiving your Property Tax Assessment from the municipality. We ask you to review your Property Tax Assessment to ensure your School Support Declaration is declared as Roman Catholic; if you are of the Roman Catholic faith.

#### Why is this important?

- By declaring your support you are exercising your right under the Constitution of Canada and the School Act to requisition municipalities for education taxes which states:
  - Individual property owners who are Roman Catholic must direct their taxes to the Roman Catholic Separate School District.
  - Individual property owners who are not Roman Catholic must direct their taxes to the Public School District.
- Taxation is a vital connection between School Boards and Electors;
- It provides a stable source of funding for public education;
- Taxes declared in support of Catholic Schools benefit your children;
- Taxes that are not declared are defaulted to the Alberta School Foundation Fund and redistributed on an equal amount per student to Public and Separate School Boards in Alberta.

How do you declare your support? Check your Property Tax Assessment Form when it arrives at your home, if it is not supporting Catholic Schools; please contact the City of Medicine Hat or the Municipality Office; then complete a School Support Declaration Form and return it to City of Medicine Hat Customer Service and Collections Department or the Municipality Office in your area. It is important to note that a Corporate School Support Declaration Form is also available for corporations who own property; the details are available from your municipality.
