site-planning meetings. Registration is ongoing, currently we have 51 English students and 100 French Immersion. We are finalizing staffing. We are continuing to develop the details of the early learning programs. October 22, 2018, will be the date for the Grand Opening Celebration, this

date is the Feast of St. John Paul II.

We have applied for a STEP Grant to support the school with administrative support and or general support in the library set up etc. The 3 modulars are approved and will be moved to the new location. We are working with the City regarding the ball field and the hockey rink. Final work on the modular should be final by August 15th. We will be ready for September 2018. We are unable to host an Open House at the school at this time, but we hope to be able to schedule that soon.

Sports Academy Review – A meeting was held on April 9th to set the terms of reference for the Sports and Fine Arts Academy review. Dr. Danny Balderson from the University of Lethbridge will develop the Sports Academy Review at a cost of \$5,000 plus expenses with the report due to the Board in Oct 2018.

Board Retreat – Surveys were sent to MHCBE stakeholders on March 12, 2018 seeking input on the Mission and Vision statement. The survey closed March 19th. We had 76 respondents about 53% were parents, with 27% teachers, only 1 Trustee and 3 administrators responded. The timeline to complete the Mission and Vision statements will move to the fall of 2018. We are hosting a Formation/Retreat day on April 24, 2018 facilitated by Ms. Bonnie Annicchiarico, Associate Superintendent of Christ the Redeemer Catholic Schools.

Superintendent and Board Evaluation – Mr. Terry Gunderson, ASBA Consultant is conducting the Superintendent and School Board Evaluation in May, he has shared the general outline and expectations for the evaluation process with the Executive Assistant. The Executive Assistant will forward the information and responsibilities prior to the Board meeting. As a reminder the date for the Board and Superintendent review is May 23, 2018 with two sessions occurring, the Superintendent evaluation discussion in the morning, and the Board evaluation in the afternoon. The Trustees are expected to be part of both sessions.

MH College First Year Students – On March 20, 2018, I was invited to speak to Medicine Hat College, First Year Education Students on three topics. These included: providing my educational story, information about the Medicine Hat Catholic School District and what does Medicine Hat Catholic look for in a new teacher. About 30 students participated in the session.

University of Lethbridge – The University of Lethbridge is planning a PS III seminar on campus, in conjunction with the Professional Inquiry Project Symposium for their graduating InternTeachers on Friday, April 20. They anticipate that they will have approximately 65 Interns in attendance, and we will have three concurrent sessions (50 minutes each), offered three times for different groups of twenty students. We have been invited to be a part of a "School District Walk-About" in order to provide us with an opportunity to connect with graduating Interns, and to talk about what we look for in new teachers and the hiring process in our school district.
