Field Trip Administrative Procedure 260 Process and Water Activities update – Over the past two years we have made significant changes to the Field Trip AP 260. This includes clarification on definitions, approval process, volunteers, and codes of conduct for students. The Superintendent presented a review of the approval process for local, provincial Canadian and International trips. We are currently reviewing our Water Activities procedures. This is a discussion at the provincial level, there is a lot of interest and engagement from school jurisidicitions. It's risk management and litigagation risk, we need the Board involved in the process.

Each March we host a Board Strategic Planning Session. The Medicine Hat Catholic Board of Education has for the past three years set Board priorities and these have guided the development of School Annual Plans and the Alberta Education Three Year Education Plan. We will use the outcome of the Board Retreat to set the priorities for the District. March 12, 2018 Board Retreat all day 9-3 p.m. April 12, 2018 Strategic Priorities 3 – 6 pm.

Education Plan Format – The the last couple of years we've had school give their education plans at the monthly Board meetings. This year the Chair of the Board received a request that the Board re- consider when presentations are made. The suggestion was to move presentations from regular board meetings to two alternate dates with 5 schools presenting one evening and 4 on the other evening. In this model we would invite administrators to hear each other's presentations as well as invite groups such as the Knights of Columbus, Catholic Women's League, and Parent Association to attend. We will develop potential dates with the schools. The presentations would be held in the parishes.
