### APPENDIX "A"

#### **CATHOLIC EDUCATION**

Note:

Donation Drive – For two weeks leading up to March 16th, MHCBE supported our local Pregnancy and Family Support Centre and the St. Vincent de Paul Society through a donation drive. All the items were taken to Holy Family Parish and then delivered to the charities by volunterrs. Staff join the parish community at the church to celebrate a Mass on March 16th beginning at 9:00. Baskets will be set up in the foyer to accept monetary donations to the St. Vincent de Paul Society. This is a wonderful way to serve others and celebrate as a community of faith. Immediately following the Mass, a visitor from Cambodia shared his work in the Indigenous Community Support Organization which is a Development and Peace partner organization.

Note:

Fourth R Training and Resources - The Public Health Agency of Canada has provided a grant to all school divisions to receive training and resources in a health and family life program called the Fourth R. This program covers all of the outcomes in our health and family life programs and has been organized into four topics: Personal Safety and Injury Prevention; Substance Use, Addictions and Related Behaviours; Healthy Eating; and Human Sexuality. It has been very well received by teachers who are currently using it. A Catholic version has recently been developed with the addition of Catholic notes so teachers are clear on the Catholic perspective of each of the topics. Bishop William has given his approval for the teaching of this program because it presents the Catholic ideal of the gift of sexuality and develops an understanding of a chaste lifestyle. It also includes a parent newsletter to encourage parents to talk with their child in the areas of dealing with pressure, relationships and decision-making. Training for the junior high teachers will take place March 14, 2018 in the afternoon.

Approximately 100 people attended, it was a very successful event. There was a lot of interest relating to our Early Learning Program. It was great to have representatives from our Early Learning Community attend to offer advice and to give information to new

parents as well as hosting an activity centre as part of the evening.

John Paul II will be the official opening celebration date for our new school. Mr. Robert Dumanowski has commenced his position as Principal of Ecole St. John Paul II School, currently working at central

office. Meetings are being held every two weeks with Mr. Dumanowski, Principal and Mr. Terry Kennedy, Vice-Principal with central office administration to review the school work plan and update the checklist. The new school will offer: Early Learning Program, M-F mornings and afternoon; K-6 English with French Immersion and a Before and After School Program.

In addition, we forward the survey link to our parents and staff via our Facebook page.
