SUPERINTENDENT'S REPORT

Note: St. Patrick's School Utilization – Over utilization continues to be an issue

at St. Patrick's School. Beginning in the 2012 – 2013 school year, a hard cap will be applied to cross attendance and registration. Students who do not live in the natural attendance zone will not be able to register unless there is a sibling that already attends and will be in the school next year;

this practice is known as "grandfathering".

Note: Rezoning St. Michael's School Medicine Hat and St. Francis Xavier

School Attendance Boundaries

Motion. Peter Grad. "THAT the Board of Trustees for the Medicine Hat

Catholic Board of Education approve that the attendance zone to St. Michael's School to include the area in Crescent Heights East of Division Avenue and North of 20th St. N.E. including Northlands to be rezoned to

St. Francis Xavier School.

Note: St. Michael's School has a fine arts focus and as a result is open to all

students division-wide, with bussing provided to eligible students from all attendance zones, parents living in this new attendance zone may continue to send their children to St. Michaels' School to access the fine arts program; those parents living in this new attendance zone that are

not interested in the fine arts program will register at St. Francis Xavier School.

Note:

Budget Priorities and Assumptions 2012 – 2013. Annually the Board work plan outlines that in January of each school year Trustees establish priorities and assumptions for the upcoming budget year. Senior Administration briefed Trustees on some of the issues relating to budget assumptions and priorities. The budget deficit currently is at \$872,269. A review of how the Division arrived at this deficit included: *unsupported support staff increases, unsupported certificated staff increases, lack of funding for special education, cuts to budget not fully restored, class size funding cuts*; among others.

Note:

Zone 6 Chair and Superintendent Meeting with the Minister of Education on Monday, December 19, 2011. The Minister talked about *Tripartite and a sustainable funding formula; infrastructure; student engagement; empty schools; transportation; community resources; achievement and diploma exams; kindergarten and high school completion.* Sometime in January 2012 a "ten point plan" will be presented by the Minister of Education.

Tripartite Negotiations – Discussions are continuing in the province between the provincial government, ASBA and the Alberta Teachers Associations. "
