## 2014 - 2015 FALL BUDGET UPDATE

Note: The Fall Budget Update was presented for Board approval. There is

forecasted to be a deficit of 1,057,518. Once the accounting effects for amortization and capitalization of building construction are included there will be a draw from the reserves of \$783,317. This draw also includes the transfer of financial assets related to the withdrawal of the Bow Island

Ward.

2939 Motion. Dick Mastel: "BE IT RESOLVED THAT the Board of Trustees for

the Medicine Hat Catholic Board of Education approve the 2014-2015 fall Update of the Budget containing a deficit of \$1,057,518 as presented and authorizes the net use of the unrestricted reserve of \$608,736 and the net use of the restricted reserve of \$200,624 to cover the 2014-2015 deficit. Included in these amounts is the authorization to transfer of up to \$90,153 to Holy Spirit School Division related to the assets associated with the ward withdrawal of St. Michael's School as determined in Ministerial Order 012/2014. Further, it is authorized to establish a capital reserve in the amount of \$26,044 related to future needs to be authorized by the Board. In addition, the Board authorizes the transfer of \$364,365 from Investment in Capital Assets to the unrestricted reserve to cover the

unsupported amortization".
