Medicine Hat Catholic Board of Education Infrastructure Maintenance and Renewal 2017-18 Amended April 10, 2018

Background

Annually the Board of Trustees for the Medicine Hat Catholic Board of Education approves the Infrastructure Maintenance and Renewal ('IMR') plan for the year. This package presents the 2017-18 recommended IMR plan along with details on the development of the plan and potential future requirements.

2016-17 IMR Plan and Actuals

In 2016-17, the Board of Trustees approved \$1,321,590 of IMR activity which included \$633,660 of new projects. At the end of the 2016-17 fiscal year \$422,194 worth of projects were completed with \$395,775 committed on approved projects to be completed in fiscal year 2017-18. In 2016-17, \$95,924 of projects were cancelled. Details of the projects and costs are outlined in Schedule 1 attached.

2017-18 IMR Plan

For the development of the 2017-18 plan, several sources were used to determine which projects were required. The government performs reviews on district school buildings every five years and develops a report outlining the work required. While some of these reports are beyond five years old, we continued to use these reports and add the results of the roofing survey we performed along with a series of locally developed needs based on our knowledge of the requirements in the buildings.

The priority projects identified from the Alberta Government reports for prior years and for the current year and next year were included for consideration. Several projects were deferred based on scheduling or for further assessment. There are potentially \$670,166 of additional projects held back as a result. None of these projects are determined to be critical.

The items being addressed as part of the modernization at Monsignor McCoy were excluded in order to allow for the modernization funds to address those issues where possible. The upgrades required at CAPE were excluded based on the unknown future use of that facility when the lease expires.

The items related to St. Thomas were included into the IMR plan pending a board decision on the consideration of school closure. In the event the board makes the decision to close the school, the \$1.143 million of planned projects would be deferred or eliminated. The Board of Trustees made the decision to close St. Thomas in January 2018 which resulted in the elimination of the planned expenditures in the amended IMR plan.

Subsequent to the development of the initial plan, there have been five new projects added to the IMR plan. The most major is with a project at St. Patrick's School for the expansion of the gym storage space at the school to deal with concerns related to storage in the mechanical room, development of an inclusive barrier free washroom and creation of additional breakout space.

In consultation with the Facilities and Operations Supervisor, the Secretary-Treasurer identified certain criteria for project determination. Required roofing repairs were selected to ensure the building envelope prevents water from leaking into the facility. Safety related and utility reduction projects were also examined for inclusion.

Another criterion was to leave a residual amount to address emergent needs which may require immediate action, such as a boiler replacement.

A degree of judgment is ultimately required to select the projects to be addressed in the year.

With regards to the specific projects proposed for 2017-18, Schedule 2 outlines the plan. The plan includes \$344,975 for completion of prior year projects and \$1,197,062 of new projects for a total budget of \$1,542,037. This will leave \$1,184,489 available for future or emergent needs.

A trial was held with allocating a school-driven allocation in order to allow for schools to address certain needs in the school. While there were positive outcomes, the restrictions on the use of IMR funds and the scale of costs constrained the school's use of the funds. As such the trial will not continue on.

The Ministry of Education in December 2017 issued new requirements regarding the use of IMR funding. Boards need to ensure at least 30% of the IMR is capitalized. This plan has 74% of the funding capitalized. The Ministry is also requiring that plans be submitted to the Ministry.

Future Projects

Projects which may need to be addressed in 2017-18 which will require future analysis are identified in the deferred projects above in the amount of \$670,166. Of the items listed, several may not be required based on the analysis.

In addition, there will be an assessment of expanding the parking at Mother Teresa School which could be a cost of \$250,000. This redesigned parking lot at Mother Teresa School may allow for off-road parking for vehicles and buses.

Deferred Projects:

The audit report from Alberta Infrastructure indicates there is \$8.9 million of deferred projects. We will continue to try to address these projects while managing other emergent needs. These are not priority areas and are based on assumed lifecycles with at least 4 years remaining at time of inspection. Examples would be replacement of fixed bookshelves which may have reached a theoretical end-life.

Recommendation

That the Board of Trustees for the Medicine Hat Catholic Board of Education approve the 2017-18 IMR plan in the amount of \$1,197,062 for new projects and \$344,975 for the previously committed projects in progress from 2016-17 as amended.
