INCLEMENT WEATHER- BUS CANCELLATION/SCHOOL CLOSURE

Background

It is expected that all schools will remain open on those days designated in the District calendars. However, bus service may be temporarily suspended and schools may be closed if the weather is severe enough to warrant an unnecessary danger to students and staff.

Procedures

- 1. At the commencement of the school year the Superintendent of Schools shall communicate in writing the following information to parents:
 - 1.1 The current procedures on Emergency Closures and Inclement Weather;
 - 1.2 Advice to the parents that their children are to be dressed warmly in severe weather;
 - 1.3 Advice to the parents that they make alternate arrangements for accommodating their children in the event that school is closed or dismissed early when parents are away;
 - 1.4 The criteria to be used by Southland Transportation and other transportation service providers for temporarily suspending service;
 - 1.5 That schools will remain open during inclement weather unless travel within the city of Medicine Hat, is not recommended;
 - 1.6 Parents have the ultimate responsibility in making the final decision on whether a student walks to school during inclement weather;
 - 1.7 If bus service is provided during inclement weather the final decision on whether a student takes the bus or not rests with the parents.
 - 1.8 A letter to Parents and Guardians is attached outlining the Inclement Weather policy of the transportation service provider and the conditions that need to exist for bus cancellation relating to road and weather conditions. The letter will be communicated to the parent community at the start of each school year.
- 2. The Principal shall establish a fan-out system for contacting parents and staff in the event of, early dismissal due to inclement weather or school closure.

- 3. In the event of an emergency school closure or early dismissal:
 - 3.1 The Principal will:
 - 3.1.1 Consult with the Superintendent;
 - 3.1.2 Notify school personnel and other appropriate people of the decision to close the school or arrange for the early dismissal of students;
 - 3.1.3 In extreme emergency situations, exercise good judgment and decide and act on his/her own; and
 - 3.1.4 Initiate communication fan-outs to ensure proper information is given regarding school closure.
 - 3.2 The Superintendent will:
 - 3.2.1 Arrange for the Bus Contractor to be notified immediately; and
 - 3.2.2 Initiate communication fan-outs to the school community via the District Website and all Social Media Platforms. In addition, the District will send emergency messaging via the Emergency Messaging App by Email, Text Messaging and Voice-Messaging. Additionally, announcements will be shared with the larger community via traditional media by television and/or radio.
- 5. In the event of inclement weather causing the cancellation of the transportation services for some students, the following procedures will apply:
 - 5.1 Staff shall be on duty if the school is open;
 - 5.2 Unless otherwise directed by the Principal, teachers shall be responsible for the direct supervision and instruction of their assigned classes for students not affected by the cancellation of transportation services;
 - 5.3 Teachers shall exercise their professional judgment in making the decision to present new material or to undertake supplementary activities when transportation services to the school are cancelled. If new material is presented, teachers shall make provision for students to attain the objectives of the material missed during their absence;
 - 5.4 Principals are to exercise their own judgment in respect of the application of attendance policies in their schools.
- 6. If weather and road conditions place the welfare of staff in some jeopardy in reaching their usual place of residence, the Principal may authorize a staff member to leave prior to normal school closing time. The Principal must ensure appropriate supervision is maintained.

Dear Parents and Guardians:

Reference: Administrative Procedure 132 – Inclement Weather – Bus Cancellation/School Closure

As part of our contract with SOUTHLAND TRANSPORTATION providing school bus service to Medicine Hat Catholic schools, SOUTHLAND is required to outline the road and weather conditions that exist for School Bus Routes to be cancelled.

The purpose of this letter is to inform you of those conditions and to make you aware of the processes used to inform parents when school busses will not be running due to inclement weather. SOUTHLAND has informed us that the causes for bus cancellation are safety related issues as a result of heavy overnight snowfall and ice on the roads. Should these conditions exist, SOUTHLAND will assess the situation at **5:30 am.** Bus route service may be cancelled for the day if SOUTHLAND determines that the heavy overnight snowfall and/or the ice on the road are detrimental to safe school bus travel.

Temperature and wind-chill in of themselves are not criteria SOUTHLAND will use for the decision to cancel bus route service for the day. Announcements about bus cancellation are communicated by the SOUTH-LAND TRANSPORTATION on local radio stations. The School District is also informed. Notification of the bus route cancellation with be posted on the district website at www.mhcbe.ab.ca and on all social media platforms @mhcatholic and in addition, the District will send emergency messages via the Emergency Messaging App by-Email, Text Messaging and Voice-Messaging.

Important Notes:

- Please ensure children are dressed warm and appropriate for inclement weather;
- Please ensure alternate arrangements are in place in the event school busses are not running;
- Parents have the ultimate responsibility in making the decision on whether children walk to school or to the school bus during inclement weather.

School Closure: Schools will remain open during inclement weather unless travel is not recommended. Schools will *only be closed* due to inclement weather when the Medicine Hat Police Service advises no travel on city streets.

- Announcements about school closure will be communicated on local radio stations
- Notification of school closure will be posted on the district website at <u>www.mhcbe.ab.ca</u> and on all social media platforms <u>@mhcatholic</u>
- Emergency messaging will be sent via School Messenger by Email, Text Messaging and Voice-Messaging.

As an ongoing reminder, it is important Parents/Guardians **OPT-IN** to **SchoolMessenger** (District Emergency Messaging App) to receive emergency notifications by text message from the school district. To receive text messages, you must opt-in; simply text **"Yes" or "Y" to 724665.**

Board Meeting

1. AERR and 3 year Education Plan for 2018-2021 - Meeting with Alberta Ed

AB Education Curriculum Implementation Plan

Since the November Board meeting, Alberta Education has provided information concerning the implementation plan for the new K-4 curriculum. The highlights include:

- a. January / June 2019 (K-4 Preparatory Phase) AB Education will prepare to pilot new curriculum. AB Ed will determine questions, methods and participants for field testing. Part of the preparation process will be looking at resources. AB Ed believes approximately 70% of approved resources will continue to be used for the new curriculum. The approved resources will be analyzed to determine appropriateness by resource committees.
- **b. September 2019 / June 2020 (K-4 Early Implementation Stage)** This is the pilot year. How schools / classes / teachers get chosen to pilot is not known at this time. (MHCBE will be looking to pilot in a number of schools) Resources/ assessments will continue to be developed.
- **c. September 2020 (K-4 Full Implementation Stage)** All teachers will be responsible for the new curriculum.

Learning Quality Standard Certification

As you are aware, the new LQS will be implemented by September 2019. Prior to September 1, 2019, teachers who are in a leadership role in the 2018/2019 school year may acquire their leadership certification in two ways:

- 1. Those working in designated principal roles during the 2018/19 school year, those are acting in the principal role for half of the 2018/19 school year, as well as principals on leave during the year: apply for a grandparented leadership certification.
- 2. Those in assistant principal, associate principal, vice-principal, or other school jurisdiction leadership roles in the 2018/19 school year: complete a one-time approved in-service training program. This training will be available throughout Alberta.

The one-time in-service training opportunities are being developed and provided through a collaborative effort by the Alberta Teachers' Association (ATA), College of Alberta School Superintendents (CASS), and Association of Independent Schools & College in Alberta (AISCA). Alberta Education will be supporting this learning opportunity, and there will be no registration costs for individuals to attend. After September 1, 2019, teachers new to leadership roles or aspiring to them, will be able to acquire leadership certification through the completion of an approved leadership training program offering by one of Alberta's post-secondary institutions.

In addition to the certification requirements, all administrators with principal or vice principal designations with MHCBE are participating in district PD to ensure all have a clear collective

understanding of the LQS. School leaders will work collaboratively on each of the following competencies; Fostering Effective Relationships, Modeling Commitment to Professional Learning, Embodying Visionary Leadership, Leading a Learning Community, Supporting the Application of Foundational Knowledge about First Nations, Metis and Inuit, Providing Instructional Leadership, Developing Leadership Capacity, Managing School Operations and Resources, and Understanding and Responding to the Larger Societal Context.

Mrs. Richard is also working monthly with division Principals, Vice Principals and Senior Leadership on increasing their capacity to provide Faith Leadership in schools.







The Solar for Schools Program provides financial rebates to Alberta Public School Authorities who install solar photovoltaic systems on existing school facilities or land in their jurisdiction and complete a student education initiative as part of the project.

The program provides funding to install rooftop solar panels with rebates of up to \$1.50 per watt on the solar energy generated to offset the school's energy costs. Increasing the amount of solar energy generated by schools supports Alberta's target of 30 per cent renewable electricity by 2030 by helping Alberta transition to an electricity system that is cleaner, reliable and more sustainable.

This program will be available to public, Catholic, francophone and charter school authorities for schools that have not received Alberta Education's Solar Technology Systems grants. RE: 2017-2018 School and Playground Trials - Next Steps

In 2014, the City of Medicine Hat (City) heard concerns from the public, school boards and users about the overall safety of its 84 school and playground facilities. At that time it was decided to complete a review of how school and playground zones function in our city. Upon completion of that review, recommendations were presented to City Council to change the effective times and move to a singular signage and thus improve consistency and clarity. In addition, the City committed to complete additional trials, which would look to improve driver and pedestrian awareness in school and playground zones through enhanced treatments. The treatments were placed in specific zones and the trials ran from August 2017 to April 2018; with data being collected before and during placement. We would like to share the results of the trials, and the next steps for school and playground safety.

Results:

Overall, there was no trial enhancement that clearly demonstrated an ability to improve driver and pedestrian awareness, as well as compliance in zones. This was in-line with the results that Calgary had when they conducted a similar trial. These results were presented to City Council in September and are captured in the attached Briefing Note.

Next Steps:

Through the trial period, it was identified that there is an on-going need to continue to engage the public and schools around zone safety. Therefore, Municipal Works will:

- Re-establish zones to original condition, through the removal of trial treatments.
 (December 2018)
- Implement an education campaign throughout 2018-2019 in collaboration with the Southeast Alberta Traffic Safety Coalition.

- Continue to review parking challenges around schools as required.
- Investigate alternative road narrowing traffic calming techniques.

Public Implications:

As part of the trials, 285 respondents completed an online public survey. A majority of the public indicated that the in road signage, flashing playground signage, and digital speed feedback signs played a significant role to enhancing safety in zones. These three enhancements were the same enhancements that had some, albeit minimal, impact on speed. Most respondents indicated that the other enhancements did not have any significant impact on enhancing safety.

BACKGROUND:

In 2014, the City of Calgary (Calgary) completed a study focusing on how enhancements to the signage in zones could affect motorists speed and awareness. Calgary reviewed 30 enhancements and selected 12 to trial at various locations throughout Calgary. They measured the motorists speed before and after the trials and engaged with the public as to awareness around zones. The conclusions reached was that there was no specific treatment in which there was a demonstrated benefit to implement on a citywide basis, and that their current level of traffic controls were appropriate for most conditions. Moving forward, Calgary determined that they would use these enhancements on a case-by-case basis where the enhancement could show improvement to safety in the community.

In 2016, the Catholic School Board requested that the City of Medicine Hat (City) review Calgary's report on the trials and further investigate if any enhancements be considered for implementation in Medicine Hat. This request was made at the same time that a review was being completed by the City on changes to its signage, times, and implementation process for zones. The City reviewed Calgary's report and decided to move forward with similar trials to see how the enhancements would work in Medicine Hat, on the basis that a smaller community may act differently than a larger community such as Calgary.

The City also had an existing program whereby five digital speed feedback signs were rotated throughout the City every six months.

City staff reviewed the 30 enhancements identified by Calgary based on defined criteria such as current conditions around playground zones, known issues and concerns, costs, passive and active options, as well as what was heard from the community in the zone review. From this assessment it was determined that six enhancements should be trialed encompassing a selected five from the Calgary's trials, and our already in-place digital speed feedback signs. The selected treatments are outlined in Attachment #1.

The trial/pilot process was as follows:

- The selection of two sites to trial each of the enhancements (12 sites in total). Two sites were selected for each enhancement to compare the results on a high and low volume roadway. The selected locations are shown in Attachment #2.
- The selection of two benchmarking sites to serve as a control for the trials.
- Meetings between City staff and school administration at the sites that were selected as trial locations. These meetings took place before and after the trials.
- The collection of background speed data between April July of 2017 (4 months).
- The installation of the enhancements at each selected location.
- The collection of speed data between August 2017 April 2018 (8 months).
- An online public survey at the end of the trial process to gain feedback from the community about the role of the enhancements in improving safety in the community.

The data collected from the trials shows that the six treatments had a minimal, if not negligible, impact on average speeds. The 85th percentile speeds were also collected. The range of the 85th percentile speeds were higher than the average speeds, ranging between 30-40 km/h. Although the average speeds do not highlight a concern, the 85th percentile speeds tell us that there are still drivers who are travelling above the speed limit. The data collected from the trials also identified that the digital speed feedback signs lost its effectiveness after approximately six months.

To summarize, the City found very similar results to that of Calgary in regards to impacting speed and the public perception. The trials highlighted three enhancements that the public believe play a role in enhancing safety in the community which were the road signs, flashing playground signs, and the digital speed feedback signs. The City also determined that these enhancements appear to have a limited impact to decreasing speed. Ultimately, there was no enhancement that had demonstrated the ability to improve driver and pedestrian awareness as well as compliance in zones.

OPTIONS CONSIDERED & POTENTIAL IMPLICATIONS:

The options which were considered are outlined below. These options provided were based on the feedback from the public that the enhancements played a role in improving safety and compares these enhancements to the costs associated with implementing them. The options are:

- Option 1: Installing two of the enhancements (flashing playground signs and in road signs) at 19 sites where concerns regarding speeding have been identified, and may be perceived as providing the most benefit to the community. The cost implement is approximately \$100K.
- Option 2: Install the in road signs and flashing playground signs citywide (86 locations). The cost to implement at all sites is approximately \$1.5M.

Option 3: Install the digital speed feedback signs citywide. The cost to purchase and initialize a
digital speed feedback sign is approximately \$7K. To implement only one digital speed feedback
sign at each of the 86 zones would cost approximately \$600K. The cost to implement a digital
speed feedback sign on each road adjacent to a zone is approximately \$2.1M.

Any of these options are scalable, and the intent is simply to provide context of costs.

However, staff do not believe that proceeding with any of these options is merited. The findings would suggest that these enhancements have limited ability to decrease speed and/or influence behaviour. Overall the enhancements would provide little value added in consideration to the benefits and costs.

Staff recognize that speeds within the City are modestly above the speed limit. Staff support continuing with the digital speed feedback sign rotation program, which costs approximately \$8K annually to run. While the impacts to changing driver behavior is similar to the other items, the program is already established and does have some impact on a 6 month basis. The speed signs assist with reinforcing awareness and likely complement the existing traffic control signage and support public perception.

IMPLEMENTATION PLAN:

Through the trials, it was identified that there is an on-going need for continued engagement and education on general rules of the road, continuing to monitor parking around schools, and the potential need to further look into alternative road narrowing and/or traffic calming treatments in which other communities have found success in mitigating parking congestion and speed. These items will allow Municipal Works to continue searching for a way to address concerns with motorists that travel over the speed limit. Therefore, Municipal Works will:

- Implement an education campaign throughout 2018-2019 in collaboration with the Southeast Alberta Traffic Safety Coalition.
- Continue, as required, to review parking challenges around schools.
- Investigate alternative road narrowing traffic calming enhancements.
- Follow-up with the schools involved in the trials.



- To present a learning environment through guidance, structured classroom lectures and distribution of educational resource materials.
- 3. To enforce the law and conduct investigations as the need arises, also to prevent crime by being a visible law enforcement presence in the school.

Program Goals:

- 1. Develop a positive rapport with the school and surrounding community. Being present in the neighboring residential areas with school administrators will enhance the positive image of police, students and staff.
- 2. Foster an improved understanding of the role of law enforcement in a free and democratic society.
- 3. Assist schools in creating a safe and secure learning environment.
- 4. Assist in the development of lockdown and evacuation protocols. Evaluate and modify the procedures as required. Attend debriefs after significant incidents.
- 5. Support Alberta Educations Safe, Secure and Caring Schools initiative, as well as the Alberta Teachers Association Safe and Caring Schools program goals, philosophy, and objectives.
- 6. Investigate offences and enforce the law as required.
- 7. Mentor, advise, and make agency referrals and conference students, school staff, and parents on issues of importance as they arise.
- 8. Act as a positive role model to students and the school community through assisting with the delivery of extracurricular school programs.
- 9. Work closely with school administrators, counseling/guidance staff on matters of mutual concern.
- 10. Prepare and present informational sessions to students and staff in a classroom setting, or assembly format which may include:
 - 10.1 Criminal Law
 - 10.2 Charter of Rights
 - 10.3 Judicial System
 - Topics of Interest (youth gangs, suicide, sex crimes, assaults and harassments, police as a career, impaired driving, drugs and alcohol, Youth Criminal Justice Act.

Statement about Policing in the Schools:

- 1. All schools ultimately fall under the direction of their own administration and therefore it is not feasible to have a policy that will cover the various needs of the school. It is important that the SRO and the school administration team on an individual basis determine an understanding of expectations.
- 2. The SRO's are available as a resource to the staff and students they are not to replace or augment school staff.

SCHOOL RESOURCER POSITION SUMMARY FOR MHCBE CATHOLIC SCHOOLS

SCHOOL RESOURCE OFFICER (SRO)

Duties and Responsibilities:

- 1. The School Resource Officers (SRO) report to the Community Resource Supervisor.
- 2. During the school term will spend each school day assigned to the schools, or working on school related duties. Recognizing that the officer has other obligations to the Police Service including training, court and crime prevention initiatives.
- The SROs should make themselves familiar with the policies within their assigned schools. (School Handbooks)
- 4. Provide a visible presence in the schools at key times before school, lunch break and after school as much as possible. To answer questions from students and staff, to listen to concerns, identify problems, and to assist in finding solutions.
- 5. Provide lectures relating to social, legal, and police related subjects. Make resource materials available as required.
- 6. Will work closely with other agencies and school resources to identify and develop intervention strategies for high-risk students: example Crisis response and Violence threat/risk assessments.
- 7. Work with student organizations and parent councils on safety, drinking and driving, drug awareness, community concerns and other relevant issues.
- 8. Will investigate complaints of criminal activity, which occur within the schools they are assigned.
- Will work to develop a good rapport with students and encourage open discussions and exchange of information.
- 10. Help provide a psychologically safe learning environment.
- 11. Be a positive role model to students at all grade levels.
- 12. Meet monthly, or as required, with school admin to review present procedures and or students at risk. To plan upcoming events related to safe and secure schools. SRO will forward updates to Community Resource Supervisor.
- 13. Participate in Attendance Board hearings as required.

Arrests:

- 1. SRO's have the same powers of arrest within the school as they do in the community.
- 2. The SRO and patrol officers will process an arrest at school in cooperation with the school administration.

Interviewing:

- 1. SRO will notify school administration when interviewing witnesses and victims within the school.
- 2. When the SRO decides after the interview a witness statement needs to be taken from the student then the parents will be notified as per district or school policy
- 3. If during the interview of a student, a criminal offence is detected, the interview will be suspended and school administration will be advised prior to a statement being taken and charter being read.

Notification of Parents:

- 1. When a young person is arrested and / or charged at school the SRO is required by law, to contact the young person's parent or guardian, as per the Youth Criminal Justice Act Section 146.
- 2. A parent will be notified prior to a criminal statement being taken from a student if the student is under the age of 18.

Declare your support

Taxes declared in support of the Catholic separate school district in your municipality benefit your children. The Constitution Acts of Canada and the Alberta School Act stipulate that individuals who are Catholic must direct their education taxes to Catholic separate school boards where they exist. If a property is jointly owned by two or more individuals of different denominations or faiths, the individuals must direct their taxes to the school boards in proportion to their ownership.

To ensure your property taxes are supporting your Catholic separate school, you must declare your school support as "separate" on your annual property assessment notice and tax bill. If a declaration of school support is not filed by a property owner, the property assessment and tax bills show the school support going to the public school district.

If your support designation is incorrect, it should be corrected by completing and submitting a School Support Declaration form, obtained online or from your local city, town or municipal office. A change in school support does not take effect until the following calendar year. You may also contact ACSTA at (780)484-6209 or admin@acsta.ab.ca and we will assist you in contacting your local Catholic school district for more information.

The Alberta Catholic School Trustees' Association (ACSTA) values the right of Catholic separate boards to requisition against the education property tax assessment base. This is an essential operation of Catholic separate boards and a vital link to their electors.

ACSTA represents all Catholic separate, Catholic public and Catholic francophone school boards and corporations in Alberta, Northwest Territories and Yukon. Our Catholic districts educate more than 175,000 students, about a third of the student population in Alberta, Northwest Territories and Yukon. We support the collaboration of family, school and parish in working to preserve and enhance the rights of Catholics to education based on the Gospel of Jesus Christ.
