Medicine Hat Catholic Board of Education Infrastructure Maintenance and Renewal 2020-2021

Background

Annually the Board of Trustees for the Medicine Hat Catholic Board of Education approves the Infrastructure Maintenance and Renewal ('IMR') plan for the year. This package presents the 2020-2021 recommended IMR plan along with details on the development of the plan and potential future requirements.

2019-2020 IMR Plan and Actuals

In 2019-2020, the Board of Trustees approved \$1,920,510 of IMR activity which included \$1,270,000 of new projects. At the end of the 2019-2020 fiscal year \$757,303 worth of projects were completed with \$994,844 committed to projects to be completed in fiscal year 2020-2021.

2020-2021 IMR Plan

As in the past IMR plans we have used several sources to prioritize projects recommended for MHCBE. Our major source is still the government audits that are usually done on a 5-year cycle and they recommend items that should be addressed in upcoming years. For roofing we continue to use a report that was authorized almost 10-years ago. With the exception of the four portables units at St. Mary's School all of the schools have been re-roofed. The portables at St. Mary's have been identified to replace based on life expectancy but there are no leaks and we are not sure of the future of the portables if that school is to be modernized.

With regards to the specific projects proposed for 2020-2021, Schedule 2 outlines the plan. The plan includes \$994,844 for completion of prior-year approved projects and \$354,421 of new projects for a total budget of \$ 1,349,266. This will leave \$512,105 available for future or emergent needs.
