Critical Worker Benefit (MacPherson)

21 Southland bus drivers also qualified for the benefit.

Fundraising for the project will be the responsibility of the Friends of McCoy Society. Should the Friends of McCoy Society raise sufficient funds to go ahead with the project the board is willing to consider leasing

the SCSL Community Center from the Friends of McCoy Society."

Catholic Board of Education are supportive of the Friends of McCoy including three existing classrooms in the preliminary design of SCSL Community Theatre in order to facilitate discussions with construction companies on project costs. Final approval for use of the classrooms will be considered when the project has enough capital to proceed and will be dependent on a number of factors, not the least of which, will be

anticipated enrollment trends at Monsignor McCoy High School."
