SCSL Established as a Strategic Priority (Leahy)

3783 Motion: David Leahy: "Be it further resolved:

- 1. That the Board of Trustees for the Medicine Hat Catholic Board of Education adopt as a strategic priority the construction of a theatre, physical literacy space, and necessary ancillary space at Monsignor McCoy High School. That the facility be named the Sisters of Charity of St. Louis Center in honor of the over one hundred years of service that the Sisters provided to the community of Medicine Hat.
- 2. That the Board of Trustees allocate \$30,000 from the 2020-2021 budget to complete a pre- construction service plan for the SCSL Center.
- 3. That while the Pre-construction report is being developed the Board of Trustees will ask for a meeting with provincial officials so that Alberta

- Education can provide direction on how this project can proceed and be in alignment with all pertinent legislation, regulations, and policy.
- 4. That the Medicine Hat Catholic Board of Education take a lead role bringing together the Catholic and greater Medicine Hat community to support this project. Key partners include the Province of Alberta, Friends of McCoy, the Medicine Hat Catholic School's Foundation, Knights of Columbus, Catholic Women's League, Parishes, Division Schools, and Community Groups. In order to exercise its leadership role, the Medicine Hat Catholic Board of Education will form a working committee of various stakeholders to achieve the goals related to this strategic priority.
- 5. That the Trustees of the Medicine Hat Catholic Board of Education work with administration to set aside capital resources to help build the project. If necessary the Trustees of the Medicine Hat Board of Education will consider issuing a debenture to finance a portion of the project. It is recognized that partners in this project will need to assist the board with significant fundraising efforts and accessing available grants. The financial support from partners may be needed to cover upwards of one half to two thirds of the cost of the project.
- 6. That final approval for the construction of this project rests solely with the Trustees of the Medicine Hat Catholic Board of Education after the necessary sign offs have been made with Alberta Education and the City of Medicine Hat.
