priority.

Note: The new grade 9 religious curriculum was developed locally (approved by

the Bishop). It was created in a Google drive for teachers to access. This year is a pilot year of the new curriculum and MHCBE will be participating

in the pilot.

Note: Mr. Mastel thanked Mrs. Irvine for organizing Faith Day.

BOARD WORKPLAN

Note: A discussion was held about the March 11th Faith Formation and

employee recognition. It was decided to leave the placement of employee recognition in March as opposed to moving it back to August Faith Day.

Note: The Board will hold their November Board meeting a week earlier

(November 2nd) due to meeting conflicts the second week in November.

Note: The first board planning meeting of the year is scheduled for September

22nd. Mrs. Lybbert will resend out the meeting request. If this date does

not work we will look at other potential dates.

Note: Deacon Risling advised the board that schools can be consecrated to

Mary in either May or October. Mrs. Irvine let the board know the consecrations have been booked with the schools for this year but this

will be looked at for future years.

INFORMATION ITEMS

International Education Update

Note: Feedback from Monsignor McCoy and St. Mary's has been very positive

regarding their international students. International Education has done a terrific job working with the students and building the program. The quality

of the homestay families has been very good.

Note: Mr. Zarichny met with staff at McCoy in June to go over any questions

they had regarding the influx of international students.

Note: There were 14 students delayed coming in September due to COVID.

They are now registered for January and are staying for an additional year. Agents from Brazil want to send students so once their border

opens we may have an influx of students.

Note: Mr. Leahy gave accolades to International Education program on what a

great job they have done.

Staffing Update

Note: Teachers have been added to St. Louis (0.5 FTE) and École St. John

Paul II (0.5 FTE). Additionally Learning Assistants have been hired at St.

Patrick's School.

Health and Wellness Update

Note: First meeting is Tuesday, September 21st. More information regarding

health and wellness will be shared at the October board meeting. November 8th will be full staff PD day focused on health and wellness.

Investments

Note: Report was included in the board agenda package.

2021-22 Enrollment Update

Note: Grade 1-12: up 11 over budget. Kindergarten: 3 over budget. PUF

budget: down 59 over budget but students are identified for PUF funding

until December 1st so that number will change.

Note: The board discussed bringing the topic of loss of grade 9 students up in

their next discussion meeting (lost 70 students 33%). MHCBE did have an inflow of 70 students from grades 5-7. Does not include international

education students (only Alberta funded students).

Note: Government will provide us with the funding for the additional students

next year (50%). Funded on a weighted average.

Johnson Controls Project

Note: Johnson Controls will present to the board at the November 2nd board

meeting about the completion of their project.

Note: Johnson Controls will now start doing data analysis on how much energy

savings we have obtained. If it is less than agreed there will be a rebate.

Sale of the Former St. Louis School

Note: A letter regarding the sale was sent to the Minister on August 31st. A

response is expected the end of the month. Possession is November 3rd.

École St. John Paul II School Utilities

Note: There has been a downward trend on usage. School is now running

efficiently and the issues have been sorted out.

Literacy and Numeracy Screening Assessments

Note: The literacy and numeracy screening assessments will be used to

address gaps in learning. There is funding available from the government

to use for subs to do intervention work.

Flag Protocol

Note: The flag protocol administrative procedures has been updated to clarify

when we should be moving our flags to half-mast.

Communications Report
